Confidentiality agreement

TERMS AND CONDITIONS

The Expression of interest for the "industry voucher" and the Terms and conditions have to be agreed and signed and then sent by email to the address vouchers@eknotproject.eu.

The last date for submission is September 15 midnight (CET). Documents provided later will not be considered.

If selected, the company will be offered **without any financial contribution** (either requested or offered), **a short term consultancy service from ONE of the four academic partners** of the e-Knot Project. This academic partner will be selected by the e-KnoT partners themselves based upon their area of expertise.

The consultancy support will be organized at distance (calls, e-mails) without any physical meeting, unless differently agreed between the company and the academic partner. **Modalities of work** will be jointly agreed.

The consultancy will be limited to a maximum of **TWENTY working days** scattered on an indicative period of **THREE months** after the start of the consultancy. The appreciation of the achievement of the resources to be spent is left at the only decision of the academic Partner.

The selection of the company will be done by the **Board of the e-KnoT Project under GSA supervision.** The four academic partners which will participate to the consultancy activities are Politecnico di Torino, Ecole Nationale de l'Aviation Civile, Universität der Bundeswehr München, Universitat Politecnica de Catalunya. The Board will be composed of these four partners and Daniel Ludwig Consultant.

Decision of the Board are irrevocable. All companies participating to the call will be informed, with no justification, of the outcome of selection.

The modalities of the protection, use and exploitation of the IPR generated during the consultancy activity, <u>if needed</u>, will be regulated by a separate agreement between the company and the e-KnoT party performing the work.

For a **period of two (2) years** from the effective date of this Agreement, in respect of any Proprietary Information received by a Party from the other Party, the receiving Party undertakes that such information shall:

- (a) be protected and kept in strict confidence by the receiving Party;
- (b) be only disclosed to and used by those persons within the receiving **Party (e-KnoT project partners)** who have a need to know and solely for the Purpose;
- (c) not be used in whole or in part for any purpose other than the Purpose;
- (d) neither be disclosed nor caused to be disclosed whether directly or indirectly to any third party or persons;

Any Proprietary Information and copies thereof shall remain the property of the disclosing Party.

The receiving Party shall have no obligations or restrictions under this Agreement with respect to any Proprietary Information which the receiving Party can prove:
